On February 19, 2013, the Calpine Gilroy Cogen, L.P. filed a <u>revised</u> petition with the California Energy Commission requesting to modify the Gilroy Cogeneration Project. The revised petition is in regard to proposed conditions of certification from the Bay Area Air Quality Management District.

The applicant previously filed a petition to amend on December 11, 2012.

The 115-megawatt project was certified by the Energy Commission on November 13, 1985 and is located in the City of Gilroy in Santa Clara County.

DESCRIPTION OF PROPOSED MODIFICATION

The modification(s) proposed in the petition would install two new Selective Catalytic Reduction (SCR) units on the project's two auxiliary boilers. The use of the new SCR units would reduce nitrogen oxides (NOx) emissions.

The Bay Area Air Quality Management District has identified that the proposed modification would result in additional air quality conditions from the district.

ENERGY COMMISSION AMENDMENT REVIEW PROCEDURES

The purpose of the Energy Commission's review process is to assess the impacts of this proposal on environmental quality, public health and safety. The review process includes an evaluation of the consistency of the proposed changes with the Energy Commission's Decision and, if the project, as modified, will remain in compliance with applicable laws, ordinances, regulations, and standards (Title 20, Calif. Code of Regulations, section 1769). Energy Commission staff is currently analyzing the request and will publish an analysis in the near future. A public hearing for the purpose of approving or denying the amendment proposal will be held at a regularly scheduled Energy Commission business meeting.

This Notice of Receipt is being mailed to interested parties and property owners adjacent to the project site who may want to participate in the amendment process.
