Dear Mr. Oglesby:

The purpose of this letter is to clarify the scope of a prior request for confidential treatment of certain emissions data filed with the California Energy Commission in connection with the Hydrogen Energy California Power Plant Project (Project). That confidentiality request was narrowly tailored to protect certain limited trade secret and proprietary data provided by the vendor of the Project's turbines and related equipment. Applicant is submitting this clarification at the request of the Kern County Planning and Community Development Department.

As background, on August 3, 2012, the Sierra Club issued Data Request No. 24 regarding certain data about the Project's estimated emissions of criteria pollutants, greenhouse gases and toxic air contaminants. Applicant initially objected to the request because it called for the disclosure of certain trade secret and proprietary information from the equipment vendor. The confidential information related to uncontrolled nitrous oxides emissions from the Project's turbine and heat recovery steam generator (HRSG) when combusting hydrogen-rich fuel and natural gas, as well as exhaust gas volume to the HRSG and feedstock dryer stacks. The confidential information represents only a very small portion of the Project's emissions data. The vast majority of the Project's emissions data had been made available to the public and was more than adequate to evaluate the environmental impacts of the Project.

In response to Applicant's objection, the Sierra Club filed a Motion to Compel, and on November 2, 2012, the CEC Committee for the Project issued the *Committee Ruling on Intervenor Sierra Club's Motion To Compel Data Responses* (Committee Ruling) requiring HECA to respond to Sierra Club Data Request No. 24 after entering into a non-disclosure agreement with the Sierra Club. In December 2012, subject to an executed non-disclosure

agreement, HECA provided emissions spreadsheets, including the confidential information, to the Sierra Club in response to Sierra Club Data Request No. 24 and the Committee Ruling.<sup>1</sup>

On January 8, 2013, HECA filed the same emissions spreadsheets provided to the Sierra Club with the CEC with a request that the confidential information be protected as such.<sup>2</sup> Updated versions of the confidential emissions spreadsheets were provided to the CEC and Sierra Club on January 10, 2013.<sup>3</sup> On the same day, HECA docketed with the CEC a non-confidential, public version of the emissions spreadsheets that contained all of the emissions data associated with the Project with the exception of the confidential information.<sup>4</sup> The CEC approved HECA's confidentiality request on January 23, 2012.<sup>5</sup>

By this letter, Applicant seeks to clarify that the request for confidentiality submitted on January 8, 2013 and approved by the CEC on January 23, 2013 was narrowly tailored to protect only the limited trade secret and proprietary data provided by the vendor of the Project's turbines and related equipment.<sup>6</sup> All other emissions data is contained in the public version of the spreadsheets docketed on January 10, 2013 and was not covered by the request for confidentiality approved by the CEC.
