Pursuant to the terms of the Commission's Order Suspending Proceeding dated June 20, 2012, Valle Del Sol Energy, LLC submits Status Report #22 for the Sun Valley Energy Project. The Sun Valley Energy Project (SVEP) is a 500-megawatt natural gas-fired peaker plant that will be located in the City of Menifee, California. The site is located on 50 acres of former farm land 30 yards southwest of the Valley Substation and will feature five General Electric LMS-100 gas turbines.

Valle Del Sol has no updates to report at this time. We are committed to working with the Commission and SCAQMD to identify a solution that will allow us to proceed with a feasible strategy. Valle Del Sol believes that SVEP represents an ideally-sited opportunity to add peaking generation to efficiently integrate renewable energy to the Los Angeles basin grid as it becomes necessary.
