**SAN GABRIEL POWER GENERATION, LLC
SUSPENSION STATUS REPORT NUMBER 19**

In accordance with the Order Suspending Proceeding dated May 15, 2012 (“Order”), the applicant in this proceeding, San Gabriel Power Generation, LLC (“San Gabriel”), submits its suspension status report number 19. The Order instructed San Gabriel to file and serve monthly status reports beginning January 2, 2013 and continuing every thirty days thereafter.

San Gabriel filed an application for certification for the San Gabriel Generating Station, a 696 megawatt natural gas-fired electricity generating facility (“San Gabriel Project”) to be located at the site of an existing power plant in Rancho Cucamonga, California, within the jurisdiction of the South Coast Air Quality Management District (“SCAQMD”). San Gabriel requested the current suspension of this proceeding due to permitting difficulties associated with the unavailability within the South Coast Air Basin of certain emission offsets needed to satisfy applicable SCAQMD rules. Those permitting difficulties still exist and emission offsets are still not available for the San Gabriel Project.

The current suspension in this proceeding is scheduled to expire on May 15, 2013. Due to the ongoing permitting difficulties referenced above, San Gabriel plans to seek a further suspension. San Gabriel will file its request before the current suspension expires.
