August 23, 2005 to May 31, 2020 – Amendment No. 1 – *updated Riverside’s Capacity procurement from 20 MW to 46 MW and extended the term an additional 7 years*

July 1, 2013 to May 31, 2020 – Amendment No. 2 – *the only change related to pricing under existing agreement. Price amended to \$69.66/MWh commencing July 1, 2013 an increase of \$7.57/MWh*
