Notice of Erratum to the *Renewables Portfolio Standard Eligibility*
Guidebook, Seventh Edition

Notice of Changes Related to Docket 02-REN-1038

The California Energy Commission adopted revisions to the *Renewables Portfolio Standard Eligibility Guidebook (RPS Guidebook)* and the *Overall Program Guidebook for the Renewable Energy Program (Overall Program Guidebook)* at its April 30, 2013, Business Meeting. The adopted revisions to the *RPS Guidebook* include the minor, non-substantive errata that were noticed on April 26, 2013, and the erratum presented by staff at the April 30, 2013, Business Meeting. In addition, the Energy Commission did not accept the proposed revisions to the *RPS Guidebook* regarding station service; consequently, the Energy Commission maintains the status quo in the *RPS Eligibility Guidebook, Sixth Edition*, regarding this issue. The erratum and proposed revisions that were not accepted are shown in Attachment A to this notice. The final adopted versions of the *RPS Guidebook* and *Overall Program Guidebook* are now available on the Energy Commission's website.

The *RPS Guidebook* explains how the Energy Commission implements and administers its responsibilities under California's Renewables Portfolio Standard. Under the law, the Energy Commission is charged with certifying eligible renewable energy resources that may be used

by retail sellers of electricity and local publicly owned electric utilities (POUs) to satisfy their RPS procurement requirements, and for developing an accounting system to verify a retail seller's or POU's compliance with the RPS. The *RPS Guidebook* also describes the eligibility requirements and process for certifying renewable resources as eligible for California's RPS and describes how the Energy Commission verifies compliance with the RPS.

The *Overall Program Guidebook* describes how the Energy Commission's Renewable Energy Program and program elements are administered and includes information and requirements that apply overall to the program elements. In the past, the *Overall Program Guidebook* also addressed aspects of the Renewable Energy Program related to the state's RPS. The sixth edition of the *Overall Program Guidebook* no longer contains RPS-related information or requirements. All RPS-related information and requirements previously included in the *Overall Program Guidebook* have now been transferred to and adopted as part of the *RPS Guidebook*. Consequently, the *RPS Guidebook* no longer includes references to information and requirements included in the *Overall Program Guidebook*.

As noted above, the adopted revisions to the *RPS Guidebook* include the minor, non-substantive erratum that was presented by Energy Commission staff at the April 30, 2013, Business Meeting. This erratum is attached and provides staff's clarification to the language in footnote 39 of page 26 of the *RPS Guidebook* related to affiliate or subsidiary entities of retail sellers or local publicly owned electric utilities for purposes of existing biomethane procurement contracts.

As a result of the adopted revisions to the *RPS Guidebook* and *Overall Program Guidebook*, it is no longer necessary for parties to reference and file comments jointly in the Energy Commission's RPS proceeding (docket no. 11-RPS-01) and Renewables Investment Plan proceeding (docket no. 02-REN-1038) when filing comments related to the RPS. These proceedings were initiated separately, but dealt with aspects of the RPS in different guidebooks; the RPS proceeding resulting in the *RPS Guidebook* and the Renewables Investment Plan proceeding resulting in the *Overall Program Guidebook* as well as guidebooks for the different Renewable Energy Program elements. Now that all the RPS-related information and requirements are included in a single guidebook, the *RPS Guidebook*, party comments going forward can be addressed as part of the RPS proceeding and limited to docket number 11-RPS-01.

Footnote 39, Page 26:

For purposes of this Existing Biomethane Procurement Contracts section, a biomethane procurement contract executed by a retail seller or POU includes a biomethane procurement contract executed by an affiliate or subsidiary entity, ~~or agent~~ of a retail seller or POU for the purpose of the retail seller or POU.

Bullet 2, Page v:

• Generation Tracking and Accounting: the treatment of station service loads is clarified.

III. Facility Requirements

A. Generation Tracking and Accounting

Page 58:

2. Station Service

Compliance with the California RPS is based on procurement from electrical generation facilities that are certified by the Energy Commission as eligible renewable energy resources. Station service, also commonly called parasitic load, generally refers to the electricity consumed by an electrical generation facility for facility operations. Electricity used by an electrical generation facility for station service is not eligible for the RPS and should not result in the creation of renewable energy credits (RECs) that are used for RPS compliance.
