On May 15, 2013 Applicant attended a Spanish language Public Hearing held by the SJVAPCD in Buttonwillow, CA to discuss the Preliminary Determination of Compliance (PDOC).

On March 21, 2013 Applicant Attended SJVAPCD Governing Board Meeting in Fresno, CA where the motion was approved to accept the Voluntary Emission Reduction and Mitigation Agreements.

III. COORDINATION OF HECA AND OXY CO2 EOR PROJECTS

Applicant corresponded with OEHI representatives regarding permitting coordination and schedule.

IV. PUBLIC OUTREACH

A number of public outreach activities have been completed by Applicant since the filing of Applicant's Status Report No. 6, including the following:

On May 7th, Applicant distributed newsletters to all residents of Buttonwillow and Tupman via postal mail in addition to sending email newsletter to more than 1,200 HECA stakeholders. Newsletters were provided in English and Spanish language and posted on the HECA website at www.heca.com The newsletter included a public notice for the May 15th SJVAPCD hearing in Buttonwillow.

On May 20th, the Taft Midway Driller editorial board issued an opinion editorial in its weekend edition May 17-20, 2013 in support of the HECA project, stating "Hydrogen Energy is a win-win proposition that makes a lot of sense." The editorial is posted on the HECA website at www.heca.com

On May 25th, Applicant sponsored a fundraiser for the Buttonwillow Little League and hosted a BBQ dinner for attendees.

On May 29th, Taft District Chamber of Commerce and Visitors Bureau issued a letter of support for the HECA project.

Applicant is participating on the Buttonwillow Community Project as a committee member. This committee is dedicated to the clean-up and revitalization of Buttonwillow and includes local business community/farmers, chamber members, law enforcement and residents.

Applicant continued participation in the local B-Safe program and the Buttonwillow Resource Center, including hosting monthly B-safe advisory committee meetings at the HECA Information Center

Applicant provided sponsorship to the local FUSE youth group and leadership program.

Applicant provided sponsorship to the Shafter Summer Baseball Program.

Applicant continues to run education advertisements in the Kern Business Journal.
