**NOTICE OF RECEIPT**  
**REQUEST TO WITHDRAW THE AMENDMENT AND TERMINATE**  
**the CALIFORNIA ENERGY COMMISSION DECISION for the**  
**CALICO SOLAR PROJECT (08-AFC-13C)**

On June 20, 2013, K Road Calico Solar, LLC, filed a letter with the California Energy Commission (Energy Commission) requesting to withdraw the amendment and terminate the Energy Commission license for the Calico Solar Project (CSP). The 663.5-megawatt project was licensed by the Energy Commission on December 1, 2010. The proposed project would be constructed on an approximate 4,613-acre site located in San Bernardino County, California. The project site is approximately 37 miles east of Barstow, 17 miles east of Newberry Springs, 57 miles northeast of Victorville, and approximately 115 miles east of Los Angeles (straight line distances).

**DESCRIPTION OF PROPOSED MODIFICATION**

The request would terminate the Energy Commission license.

**ENERGY COMMISSION REVIEW PROCEDURES**

The purpose of the Energy Commission's review process is to receive any comments relating to the granting of the request. A public hearing for the purpose of approving or denying the request will be held at the **August 14, 2013** Energy Commission business meeting. If the request is approved, the Energy Commission's order will also be posted on the webpage.
