**ORDER INSTITUTING INFORMATIONAL PROCEEDING**  
**January 15, 2014**

**I. Introduction**

Senate Bill 1389 (Stats. 2002, Ch. 568), enacting Public Resources Code § 25300 et seq. requires the Energy Commission to "conduct assessments and forecasts of all aspects of energy industry supply, production, transportation, delivery and distribution, demand, and prices. The Energy Commission shall use these assessments and forecasts to develop energy policies that conserve resources, protect the environment, ensure energy reliability, enhance the state's economy, and protect public health and safety. To perform these assessments and forecasts, the commission may require submission of demand forecasts, resource plans, market assessments, and related outlooks from electric and natural gas utilities, transportation fuel and technology suppliers, and other market participants." (Public Resources Code § 25301[a]).

**II. Purpose and Scope of the Proceeding**

Pursuant to Public Resources Code section 25210 and Title 20, California Code of Regulations, section 1222, the Energy Commission hereby institutes an informational proceeding to gather and assess information to assist the Energy Commission in preparation of the *2014 Integrated Energy Policy Report Update (2014 IEPR Update)*, which is required pursuant to Public Resources Code section 25302(d) and *2015 IEPR* which is required pursuant to Public Resources Code section 25302(a). The adoption of this order will ensure that the Lead Commissioner assigned to this proceeding can collect information related to specific topics that will be addressed in the *2014 IEPR Update* and *2015 IEPR*.

The IEPR Lead Commissioner will identify the specific topics that are of interest in the respective 2014 and 2015 IEPR proceedings in a formal Scoping Order that will be released for the *2014 IEPR Update* in early 2014 and for the *2015 IEPR* in early 2015.

**III. IEPR Workshops**

The data of the first hearing is undetermined, but the IEPR Lead Commissioner expects to hold workshops throughout 2014 for the *2014 IEPR Update* and throughout 2015 for

the 2015 IEPR. The IEPR Lead Commissioner will provide notice at least ten days in advance of any workshop and hearings and will identify when written comments and/or testimony will be due, as well as the manner of filing.

#### **IV. Public Participation**

The Energy Commission encourages public participation in these proceedings. Any person present at any hearing or workshop shall be afforded a reasonable opportunity to make oral comments on the subject matter of the event. Additionally, the Lead Commissioner will provide notice of the opportunity to file written comments and/or testimony on identified topics.
