Agenda

This workshop will discuss the latest findings on the vulnerability of California's transportation system to climate change and steps being taken to prepare for potential impacts.

Background

California's transportation system includes major freeways, rail corridors and ports. Climate change may impact all facets of the transportation system including roads, bridges, tunnels, rail, public transportation, air transport, the vehicles that use these facilities and the fuel networks they depend on.

Much of our infrastructure was constructed without consideration of the impacts of climate change. As climate impacts are felt in the coming years, the state's transportation network faces the threat of disruption. In particular, sea level rise and storm surge are expected to be significant issues for California with the potential for flooding of nearly 3,500 miles of roadways and 280 miles of rail lines and posing threats to ports and harbors as well as vital fuel infrastructure. Additionally, extreme heat events affect the infrastructure durability and fires and extreme storms can impact infrastructure and lead to delays.

Caltrans is leading state efforts to mitigate impacts to the transportation system. For more detail, see the draft [Safeguarding California](#) report.
