Subject:	BUILDINGSTANDARDS-LIST: Notice of Intent to Adopt a Negative Declaratic Availability of the Initial Study and Start of the Public Comment Period	

The California Energy Commission is considering adopting revisions to the California Building Energy Efficiency Standards (Standards), codified in Title 24, Part 1, Chapter 10, and Part 6, of the California Code of Regulations. Energy Commission staff prepared an Initial Study to document the potential impacts of the proposed revisions to the Standards and has analyzed the potential environmental impacts that are likely to result if the revisions are adopted. Staff's recommendation to the Energy Commission is to adopt a Negative Declaration based on the contents of its Initial Study.

The public comment period for this Initial Study and Proposed Negative Declaration will be from February 27, 2015, through 10:00 a.m. on March 30, 2015.
