On March 25, 2015, the City of Roseville submitted a compliance filing requesting the Energy Commission find that the City of Roseville's power purchase agreement with Powerex Corporation for electricity from a biomethane project in Washington State be determined to be compliant with the Energy Commission's Greenhouse Gases Emission Performance Standard (EPS).

#### STAFF RECOMMENDATION

The power purchase agreement is for a long-term investment with Powerex Corporation for renewable energy from a biomethane project in Washington State.

The details of the power purchase agreement are as follows:

H.W. Hill Landfill Gas (also known as Roosevelt Biogas I): 26.0 MW representing 100 percent of the facility output starting on January 1, 2016 and ending on December 31, 2025. The counterparty is Powerex Corporation.

Staff completed a review of the compliance filing and determined that the contract is compliant with the Emission Performance Standard pursuant to Section 2903(b), which states that, "any in-state or out-of-state power plant that meets the criteria of a renewable electricity generation facility as defined in Chapter 8.6 of Division 15 of the Public Resources code is deemed to be compliant." The biomethane facility specified in the compliance filing is RPS Certified and meets this requirement. Therefore, staff recommends the Energy Commission find that the covered procurement described in the compliance filing complies with the Energy Commission's Greenhouse Gases Emission Performance Standard, Title 20, section 2900 et seq., of the California Code of Regulations.

### **ENERGY COMMISSION FINDINGS**

Based on staff's analysis, the Energy Commission concludes that the City of Roseville's PPA complies with the Energy Commission's Emission Performance Standard. The Energy Commission finds that:

- The compliance filing meets all of the filing criteria of Title 20, section 2909, of the California Code of Regulations; and
- The Power Purchase Agreement identified in the compliance filing is compliant with the EPS because the facility under contract is an RPS Certified renewable energy facility and is determined to be compliant with the EPS pursuant to Title 20, section 2903(b)(1), of the California Code of Regulations.

#### **CONCLUSION AND ORDER**

The California Energy Commission hereby adopts staff's recommendation and finds that the covered procurement described in the compliance filing complies with the Energy Commission's Greenhouse Gases Emission Performance Standard, Title 20, section 2900 et seq., of the California Code of Regulations.
