Subject: EFFICIENCY-LIST: Notice of Intent to Adopt a Negative Declaration; Availability of the Initial Study and Start of the Public Comment Period

The California Energy Commission is considering adopting revisions to the nonresidential lighting alteration provisions of the California Building Energy Efficiency Standards (Standards), codified in Title 24, Part 6, Sections 141.0(b)2I, J, K, and L of the California Code of Regulations. Energy Commission staff prepared an Initial Study to document the potential impacts of the proposed revisions to the Standards and has analyzed the potential environmental impacts that are likely to result if the revisions are adopted. Staff recommends that the Energy Commission adopt a Negative Declaration based on the contents of its Initial Study.

The public comment period for this Initial Study and Proposed Negative Declaration will be from July 10, 2015, through 10:00 a.m. on August 10, 2015. A full copy of the Notice of Intent to Adopt a Negative Declaration is available at www.energy.ca.gov/title24/2016standards.html.
