**2016 TITLE 24 BUILDING ENERGY EFFICIENCY  
STANDARDS RULEMAKING PROCEEDING

**ENERGY COMMISSION DOCKET NUMBER 15-BSTD-01**

*A. Pursuant to Government Code section 11346.4, subd. (a), 1 Cal. Code Regs., section 86, and Government Code section 11104.5, subd. (a), at least 45 days before the close of the public comment period on the adoption of the proposed 2016 revisions to the California Building Efficiency Standards, Title 24 of the California Code of Regulations, Parts 1 and 6, the Energy Commission provided notice of this proposed action to the following persons in the manner indicated:*

*(1) Every person who has filed a request for notice of regulatory actions with this agency;*

No one requested written notice, however this notice was provided via email on February 27, 2015 to the efficiency and building standards list serve which consists of all those who have expressed an interest in Energy Commission actions related to these regulations. This notice directs readers to the Commission website which affords the opportunity to subscribe to the Commission list serve.

The notice was also posted on the Energy Commission's website on February 27, 2015.

*(2) The Secretary of the Resources Agency;*

This notice was provided via written document on January 12, 2015.

*(3) A representative number of small business enterprises or their representatives that are likely to be affected by the proposed action; and*

This notice was provided via email to the efficiency and building standards list serve which consists of many small businesses that have expressed an interest in Energy Commission actions related to these regulations.

The notice was also posted on the Energy Commission's website on February 27, 2015.

*(4) All persons and groups of persons whom this agency believes to be interested in this proposed action.*

All persons who requested notification from the Energy Commission of the availability of changes were directed to subscribe to the Energy Commission Building Standards list-server. No persons objected to this form of notice. This was done in the manner normally and consistently used by the Energy Commission.

*(5) The Secretary of the Resources Agency;*

This notice was provided via written document on January 12, 2015.

The notice and text of the proposed changes to these regulations from that which were originally proposed were made available at the Energy Commission and on its internet website on May 27, 2015. The notice and text of two proposed additional changes to the Nonresidential Lighting Alteration provisions were made available at the Energy Commission and on its internet website on June 10, 2015 and October 27, 2015.
