

## NOTICE OF RECEIPT

WIND IN DOCKETS

The California Energy Commission has received a petition from the Sacramento Municipal Utility District (SMUD) requesting approval to transfer the SMUDGEO #1 Geothermal Power Plant license (80-AFC-1C), and the obligations imposed by the conditions of certification, to Calpine Geysers Company, L.P.

## **Commission Review Procedures**

A statement describing the ownership change, signed under penalty of perjury by a representative of the proposed new owner of the project, was submitted to the Energy Commission staff for review and approval as required by Title 20, California Code of Regulations, section 1769(b). The statement affirms that the new owner agrees to be bound by the requirements of the Energy Commission for the SMUDGEO #1 project.

Based on the information provided, staff intends to recommend that the proposed ownership change be approved by the Energy Commission at the June 24, 1998 business meeting.
