Background

Energy Commission staff published *The Comprehensive Energy Efficiency Program for Existing Buildings Scoping Report* in August 2012, and held workshops in October 2012 to receive public comments. Staff evaluated and incorporated stakeholder comments in *The Comprehensive Energy Efficiency Program for Existing Buildings Draft Action Plan.* This original draft was presented during three public workshops held across the state on June, 24, 25, and 28, 2013. Additional stakeholder input was received and elements were
