## **Background**

Energy Commission staff published *The Comprehensive Energy Efficiency Program for Existing Buildings Scoping Report* in August 2012, and held workshops in October 2012, to receive public comments. Staff evaluated and incorporated stakeholder comments in *The Comprehensive Energy Efficiency Program for Existing Buildings Draft Action Plan.* This original draft was presented during three public workshops held across the state on June 24, 25, and 28, 2013. Additional stakeholder input was received and incorporated

into the current draft which was released on March 6, 2015, and is available at: <a href="http://www.energy.ca.gov/2015publications/CEC-400-2015-013/CEC-400-2015-013-0.pdf">http://www.energy.ca.gov/2015publications/CEC-400-2015-013/CEC-400-2015-013-0.pdf</a>. A workshop will be held on April 7, 2015, where an overview of the *Action Plan* will be presented and stakeholder comments received.

The *Action Plan* provides a ten-year roadmap to dramatically increase energy efficiency in existing residential, commercial, and public buildings. The *Action Plan* is consistent with Governor Edmund G. Brown Jr.'s goal to double efficiency in California's existing buildings by 2030. The Energy Commission will partner with the California Public Utilities Commission, local governments, industry stakeholders, and various state and local agencies to achieve the *Action Plan's* objectives.

### **Agenda**

This workshop will present strategies for improving data access to enable consumer action, market innovation, and state and local policies. The morning session of this workshop will cover strategies to inform consumer action and enable market innovation, while the afternoon session will cover strategies to drive state and local policies. Staff will facilitate presentations from experts within each area of discussion. Participants will present innovative practices for data access, such as current tools, infrastructure, pilots, and policies, which can help advance the vision and goals established in the *Action Plan*.
