### **Background**

Following the lowest snowpack ever recorded in California history and with no end to the multi-year drought in sight, Governor Brown signed <a href="Executive Order B-29-15">Executive Order B-29-15</a> on April 1, 2015, directing first-ever statewide, mandatory water reductions. The Executive Order directs the California Energy Commission, jointly with the Department of Water Resources and the California Water Board, to implement a time-limited statewide appliance rebate program to provide monetary incentives for the replacement of inefficient household devices.

The time-limited, statewide appliance rebate program will provide monetary incentives for the replacement and early retirement of inefficient clothes washers for residences. This new rebate program will help California capture water savings, as well as reduce greenhouse gas emissions, which are thought to have contributed significantly to the current change in climate.

Jointly with the Department of Water Resources and the Department of Community Services & Development, the Energy Commission is also developing a time-limited statewide water saving appliance and fixture direct installation program to replace inefficient household water devices on a no-cost basis for income-qualified households.

The Department of Water Resources is developing a toilet replacement program targeted at replacing inefficient toilets with more efficient toilets. The Department of Water Resources is also developing a turf replacement program throughout the state.

The Energy Commission requests public input related to the appliance rebate program and direct installation guidelines; and the Department of Water Resources requests input related to the toilet rebate and turf replacement programs.

<u>Oral comments</u>. Staff will accept oral comments on the programs during the workshop. Comments may be limited to three minutes per speaker. Any comments may become part of the public record in this proceeding.

<u>Written comments</u>- Written comments will be accepted at the workshop however, staff may not have time to review them before the conclusion of the meeting.
