NOTICE OF POSTPONEMENT OF HEARING FOR CONSIDERATION AND POSSIBLE ADOPTION AND EXTENSION OF COMMENT PERIOD

Proposed Amendments to Appliance Efficiency Regulations California Code of Regulations, Title 20, Sections 1601 through 1609

Docket No. 15-AAER-6

The Notice of Proposed Action¹ issued on October 16, 2015, set a date of December 9, 2015, for consideration and possible adoption by the California Energy Commission of the proposed amendments to the Appliance Efficiency Regulations of Title 20 of the California Code of Regulations relating to energy efficiency standards for general service Light-Emitting Diode (LED) lamps and small-diameter directional lamps, and consideration and adoption of the proposed Negative Declaration, including a Finding of No Significant Impact under the California Environmental Quality Act (CEQA), for those proposed amendments. The Commission will not consider adoption of these matters on December 9, 2015, and the hearing date for consideration and possible adoption of both the proposed amendments and the Negative Declaration has been postponed to January 13, 2016. This will allow for additional time to review and consider comments received during the comment period, and to determine whether changes to the proposed amendments are warranted.

The comment period will also be **extended an additional 7 days**. The public comment period will not close on November 30, 2015 as originally intended; instead, **the public comment period will close at 4 p.m. on December 7, 2015.**

This postponement is authorized by Section 11346.8(b) of the California Government Code. If changes are made to the proposed amendments pursuant to Section 11346.8(c) of the California Government Code, the full text of the amendments, with the changes clearly indicated, will be made available to the public for at least 15 days prior to the hearing scheduled for consideration and possible adoption of the proposed amendments.
