Notice of Opportunity to Comment on the 2016 Building Energy Efficiency Standards Lighting Alteration Subchapters in the Nonresidential Compliance Manual and Documents

The California Energy Commission is providing interested parties with the opportunity to review and comment on the draft Nonresidential Compliance Manual Subchapters 5.9 and 6.5, and the compliance documents, relating to indoor and outdoor lighting alterations.

Background

The Energy Commission adopted the *2016 Building Energy Efficiency Standards* Nonresidential Indoor and Outdoor Lighting Alterations language on November 12, 2015. Staff, with input from the stakeholders, revised the compliance manuals and compliance documents to address the 2016 updates.

The public is now invited to provide comments on the lighting alteration subchapters in the nonresidential compliance manual and related compliance documents. The close of this comment period will be March 15, 2016. Updates are displayed in underline and strikethrough for ease of review.

The *2016 Nonresidential Compliance Manual* and compliance documents are intended to assist plans examiners, inspectors, owners, designers, builders, and energy consultants. The manual is written as a reference and instructional guide and can be helpful for anyone that is directly or indirectly involved in the design and construction of energy efficient nonresidential buildings.
