**Notice of Joint Agency Workshop on Senate Bill 350  
Low-Income Barriers Study Implementation**

The California Energy Commission and the California Public Utilities Commission (CPUC) will jointly conduct a workshop to discuss implementation of the *Low-Income Barriers Study, Part A: Overcoming Barriers to Energy Efficiency and Renewables for Low-income Customers and Small Business Contracting Opportunities in Disadvantaged Communities (“Barriers Study”)*. The Barriers Study was mandated by Senate Bill 350 (de León, Chapter 547, Statutes of 2015), the Clean Energy and Pollution Reduction Act of 2015. The Barriers Study was published in December 2016 and is available on the Energy Commission’s website at: [www.energy.ca.gov/sb350/barriers\\_report/](http://www.energy.ca.gov/sb350/barriers_report/).

Chair Robert B. Weisenmiller is the Lead Commissioner for the 2017 IEPR, and he will be joined by Commissioner Janea A. Scott, who has been assigned as the Lead Commissioner for Barriers Study Implementation. This workshop will be jointly conducted with the CPUC, with Commissioner Cliff Rechtschaffen serving as the CPUC Lead Commissioner. A representative from California Air Resources Board may also be in attendance. Other Commissioners at the Energy Commission and the CPUC may also attend and participate in the workshop. A quorum of Commissioners from the CPUC and/or the Energy Commission may be in attendance, but no votes will be taken.

**Background**

Governor Edmund G. Brown Jr. signed the Clean Energy and Pollution Reduction Act of 2015 (SB 350) on October 7, 2015. The bill establishes new energy efficiency and renewable electricity

targets by 2030 to support California's long-term climate goal of reducing greenhouse gas emissions by 80 percent below 1990 levels by 2050. The bill also finds that there is insufficient understanding of the barriers for low-income and disadvantaged communities to access energy efficiency investments, solar photovoltaic energy generation, weatherization, other forms of renewable energy, clean transportation options, and contracting opportunities for small businesses located in disadvantaged communities.

For this reason, SB 350 directed the Energy Commission and California Air Resources Board (ARB) to complete and publish studies on the following topics:

- Barriers to and opportunities for solar photovoltaic energy generation as well as barriers to and opportunities for access to other renewable energy by low-income customers.
- Barriers to contracting opportunities for local small businesses in disadvantaged communities.
- Barriers for low-income customers to energy efficiency and weatherization investments, including those in disadvantaged communities, as well as recommendations on how to increase access to energy efficiency and weatherization investments to low-income customers.
- Barriers for low-income customers to zero-emission and near-zero-emission transportation options, including those in disadvantaged communities, as well as recommendations on how to increase access to zero-emission and near-zero-emission transportation options to low-income customers, including those in disadvantaged communities (addressed in Part B of the Barriers Study, completed by ARB).

The Barriers Study, Part A, was adopted by the Energy Commission at the business meeting held on December 14, 2016. The final report contains twelve recommendations that encourage state agencies to pursue promising approaches to addressing the challenges faced by low-income customers, including those in disadvantaged communities, in accessing clean energy and the associated benefits it enables.

Part B of the Barriers Study was developed by ARB to address the final bullet described above. A draft guidance document was published by ARB on April 12, 2017, and is available on the ARB website at: <https://www.arb.ca.gov/msprog/transoptions/transoptions.htm>.

## **Agenda**

The workshop will feature presentations and panel discussions to help inform implementation of the recommendations included in the Barriers Study. Energy Commission and ARB staff will provide an overview of the Part A and Part B reports, respectively. Panels will be composed of industry experts, utility representatives, environmental organizations, community-based organizations, and others with relevant knowledge on the issues affecting low-income customers and clean energy opportunities. The presentations and panel discussions will focus on a subset of the report recommendations, with panels focused specifically on potential solutions for low-income multifamily buildings, regional outreach and one-stop shop pilots, labor and workforce development, and innovative financing pilots for low-income clean energy customers.
