# **Background**

The purpose of this workshop is to present information and solicit comments on proposed changes to the *Guidelines for California's Solar Electric Incentive Programs* (Senate Bill 1). Proposed changes in this edition of the SB 1 Guidelines, as compared with the November 2016, Sixth Edition, include:

- Edits and additions to equipment standards and testing requirements to address:
  - o Smart Inverter, Rule 21, Phase 2 (Communications)
  - Smart Inverter, Rule 21, Phase 3 (Advanced Functions)
  - New required PV module safety standard (UL 61730)
  - o New PV module performance standard (IEC 61853)
  - New optional PV module design qualification standard (IEC 61215)
- Revisions to reporting of temperature coefficients
- Additional clarifications specific to the listing of equipment

A draft of the proposed revisions to the existing guidelines will be posted on the Energy Commission website prior to the workshop at <a href="http://www.energy.ca.gov/sb1/documents/index.html">http://www.energy.ca.gov/sb1/documents/index.html</a>.

SB 1 (Murray, Chapter 132, Statutes of 2006) requires the Energy Commission to establish eligibility criteria, conditions for incentives, and rating standards for projects applying for ratepayer-funded incentives for solar energy systems. The *SB 1 Guidelines* provide a framework for the California Public Utilities Commission's (CPUC) California Solar Initiative Program, the Energy Commission's New Solar Homes Partnership (NSHP), and publicly owned utilities' (POU) solar energy system incentive programs. The initial *Guidelines for California's Solar Electric Incentive Programs Pursuant to Senate Bill 1* were adopted in December of 2007, and have been updated periodically to address program modifications and market developments.
