## **Notice of IEPR Staff Webinar on Forms and Instructions to Collect Electricity Demand Forecast and Electricity Resource Plan Data from Load-Serving Entities**

The California Energy Commission staff will conduct a webinar to solicit comments on proposed data collection and analyses for the *2019 Integrated Energy Policy Report (2019 IEPR)* relating to electricity demand forecasts and resource plans on:

### **Background**

The Energy Commission is directed by California Public Resources Code Section 25301 to regularly assess all aspects of energy demand and supply in order to develop energy policies that conserve resources, protect the environment, ensure energy reliability, enhance the state's economy, and protect public health and safety. These assessments are the foundation for analyses and policy recommendations to the Governor, Legislature, and other agencies. To carry out these assessments, "the Commission may require submission of demand forecasts, resource plans, market assessments, and related

outlooks from electric, natural gas utilities, transportation fuel and technology suppliers, and other market participants” (California Public Resources Code Section 25301(a)(2)).

Under the Energy Commission’s regulations, each load-serving entity (LSE) is required to submit a 10-year demand forecast according to forms and instructions adopted by the Energy Commission. (Cal. Code Regs, tit. 20 § 1345.) All LSEs are also required to submit 10-year resource plans according to forms and instructions adopted by the Energy Commission. (Cal. Code Regs, tit. 20 § 1347.) Cal. Code Regs, tit. 20 § 1350 provides an exemption from these filing requirements to small LSEs (those with a peak electricity demand of less than 200 MW in both of the two calendar years preceding the filing) if those entities have provided the resource adequacy information identified in Cal. Code Regs, tit. 20 § 1346.

This information will provide a foundation for the analyses and recommendations in the *2019 IEPR*, including resource assessment and analysis of progress towards energy efficiency and renewable energy goals. The data will also be used to develop Energy Commission forecasts, which are used in the California Public Utilities Commission procurement and resource adequacy proceedings, as well as in transmission planning studies conducted by the California Independent System Operator. This information will also provide the Energy Commission with a better understanding of LSE planning assumptions and supply resource commitments, allowing the Energy Commission to assess current conditions in electric generation system infrastructure needs and to identify major statewide trends affecting electricity supply and reliability. Demand and Supply forms and instructions will be posted to their respected dockets (19-IEPR-02 and 19-IEPR-03) a few days prior to the webinar.

## **Agenda**

On October 2, 2018, Energy Commission staff from the Energy Assessments Division will present proposed changes to both its electricity demand forecast and energy resource plan forms and instructions. The webinar will start with an introduction followed by the first presentation on the electricity demand forecast forms and instructions. The second presentation will be on the electricity resource plan forms and instructions. After each presentation, there will be time for participant discussion and comments.

## **Public Comment**

**Oral Comments:** There will be an opportunity for oral comments during the webinar. Any comments will become part of the public record in this proceeding.

**Written Comments:** Written comments should be submitted to the Dockets Unit by **5:00 p.m. on October 12, 2018**. All written comments will become part of the public record of this proceeding.
