Agenda

At the January 17, 2019, workshop, two panels of experts will focus on California's economics, demographics, and business climate. The first panel of economic and demographic forecasters will discuss California's projected future economy and California's changing population characteristics. The second panel will be comprised of industry representatives who will focus on the state's economy from the business perspective. A moderator will present questions covering major economic and demographic issues to these two expert panels.

There will be time at the end of each panel discussion for questions from the public. This workshop will provide an opportunity for energy demand forecasters, Energy Commission staff, and others to obtain further insight on possible economic and demographic

outcomes in California. The information gained from this workshop will enhance the 2019 California Energy Demand Forecast.

Background

California Public Resources Code section 25301 requires the Energy Commission to prepare an *IEPR* every two years that includes assessments and forecasts of all aspects of energy industry supply, production, transportation, delivery and distribution, demand, and prices. The Energy Commission develops these assessments and forecasts of the state's electricity and natural gas markets, including statewide and regional electricity and natural gas demand, incorporating factors leading to future demand growth, such as changes in economic activity, population growth, urban development, industrial expansion and energy intensity, growth in different building types, and energy and environmental policies.

Public Comment

Oral Comments: In addition to time provided at the end of each panel presentation for questions, Commissioners will accept oral comments at the end of the workshop. Public comments may be limited to three minutes or less per speaker, and to one person per organization. If participating via WebEx, use the "raise hand feature" so the administrator can introduce you and unmute your microphone after comments from the floor.
