## **Notice of Availability Burbank Water and Power Integrated Resource Plan Filing Docket No. 18-IRP-01**

Senate Bill 350 (SB 350) (de León, Chapter 547, Statutes of 2015) requires publicly owned utilities (POUs) with annual electrical demand exceeding 700 gigawatt hours to adopt integrated resource plans (IRPs) by January 1, 2019. POU IRPs must be submitted to the Energy Commission for review by April 30, 2019. POU IRPs submitted to the Energy Commission will be posted for 30 calendar days for public comment.

Upon receipt, the Energy Commission will review the IRP and determine whether it is consistent with the requirements of SB 350. The Energy Commission will consider requirements in the IRP Guidelines as well as public comment related to the consistency of the IRP with SB 350 requirements as part of its review and determination.

On April 1, 2019, Burbank Water and Power (Burbank) submitted its complete IRP filing to the Energy Commission, including the four standardized reporting tables. Burbank re-submitted their standardized reporting tables on April 24. The standardized reporting tables provide data on capacity and energy resources each POU plans to use and the projected progress towards greenhouse gas emission reduction targets. The reporting tables provide supporting information for the Burbank IRP.

Interested stakeholders may submit written comments to the Dockets Unit by **5:00 p.m. on June 13, 2019**. The Energy Commission is using an electronic commenting system to accept comments. Please follow the instructions below to provide written comments.

3. Type "**18-IRP-01**" into the Select a Proceeding field.

5. Comment title should be “Jane Doe or Company Name Comment on Modesto IRP.”
6. Type comments into the “Comment Text” field or upload a document with comments. Comments should be in a downloadable, searchable format such as Microsoft® Word (.doc or .docx) or Adobe® Acrobat® (.pdf).
7. Enter the CAPTCHA that is used to prevent spamming on the website. Then click on “Agree and Submit your Comments.”
