## Background

California's EV charging station permit streamlining law (Assembly Bill (AB) 1236 Statutes of 2015, Chapter 598) was enacted to address the needs of EV charging station providers to streamline the permitting process; the need for better information from applicants, and a directive to create streamlined processes. To help address these challenges, AB 1236 established requirements for the permitting process and communication methods for cities and counties, essentially putting best practices into statute. Communities need to implement AB 1236 and improve upon its requirements by sharing lessons learned and best practices. The EV charging industry is rapidly evolving and its success hinges on ongoing dialogue and process improvements.

The CPUC's current Development of Rates and Infrastructure for Vehicle Electrification (DRIVE) Rulemaking (<u>R.18-12-006</u>) focuses on better alignment of internal and external state agency resource planning processes, including permitting alignment efforts, while addressing the role of the investor-owned utilities in meeting the state's EV adoption targets and greenhouse gas emission reduction goals.

This workshop will share lessons learned, resources, and information about the importance of streamlining the permitting and installation processes for EV chargers from different permitting jurisdictions and state agencies.
