Staff will discuss research initiatives across all natural gas research areas including: energy efficiency, renewable energy, natural gas infrastructure and safety, natural gas-related environmental research, and natural gas-related transportation research.

Feedback will be gathered on the proposed natural gas research initiatives from utilities, researchers, manufacturers, end-users, environmental and consumer representatives, policymakers from state agencies, federal agencies, California based organizations and members of the public. Commissioners may attend the workshop, but no votes will be taken.
