This is to inform you that on February 11, 2020, the Modesto Irrigation District (MID) Board of Directors, at a noticed public meeting, approved and authorized the execution and delivery of a Senate Bill 859 (SB 859) Purchase Agreement between MID and Roseburg Forest Products Co. for 11 megawatts of capacity associated with an existing biomass-fueled generation station located near Weed, California. The Purchase Agreement information is as follows:
