# Staff Report Mechanical Acceptance Test Technician Certification Provider 2019 Updates Review: California State Pipe Trades Council CEC-400-2020-004

The 2016 Building Energy Efficiency Standards (Energy Code), §10-103.2(d)2, requires that approved acceptance test technician certification providers (ATTCPs) submit a 2019 update report to the California Energy Commission (CEC) detailing what adjustments have been made to the training curricula to address adopted updates to the Energy Code. ATTCPs must demonstrate that their acceptance testing certification services will comply with applicable updates to the Energy Code. The 2019 update reports are subject to the amendment process in Section 10-103.2(f) of the 2016 Energy Code, as the reports are due prior to the January 1, 2020, which is the effective date of the 2019 Energy Code. Amendments containing any substantive changes must be reviewed and approved under the same process as new ATTCP applications in Section 10-103.2(e).

CEC staff has evaluated the training curricula adjustments and other application amendments that the California State Pipe Trades Council (CSPTC) submitted in its 2019 update report for compliance to Section 10-103.2(c) of the 2019 Energy Code. CSPTC's 2019 update report includes application amendments that make nonsubstantive and substantive changes. Staff has found that CSPTC's update report complies with all applicable requirements in the 2019 Energy Code. Staff recommends that the CEC approve the training curricula adjustments and other application amendments CSPTC is proposing in its 2019 update report.

Section 10-103.2(e)3 of the 2016 Energy Code requires the CEC to give all interested persons a copy of staff's evaluation and provide reasonable opportunity for public comment. As such, the CEC is posting a staff report on the review and evaluation of CSPTC's 2019 update report.

The staff report is available free on the CEC's ATTCP update reports webpage.
