Notice of Availability and Request for Comments

Draft 2020 Integrated Energy Policy Report (IEPR) Update, Volume III: California Energy Demand Forecast Update

The California Energy Commission (CEC) seeks public comments on Volume III of the *Draft 2020 Integrated Energy Policy Report Update (Draft 2020 IEPR Update)*. The *Draft 2020 IEPR Update, Volume III: California Energy Demand Forecast Update* is available on the CEC's 2020 IEPR Update [web page](https://www.energy.ca.gov/data-reports/reports/integrated-energy-policy-report/2020-integrated-energy-policy-report-update-0) at <https://www.energy.ca.gov/data-reports/reports/integrated-energy-policy-report/2020-integrated-energy-policy-report-update-0>.

The *Draft 2020 IEPR Update, Volume I: Blue Skies, Clean Transportation*, was posted January 6, 2021, and is available on the same web page. The *Draft 2020 IEPR Update, Volume II: The Role of Microgrids in California's Clean and Resilient Energy Future* will be available at a later date.

Background

Public Resources Code Section 25301 requires the CEC to prepare an IEPR every two years that includes assessments and forecasts of all aspects of energy industry supply, production, transportation, delivery and distribution, demand, and prices. The CEC uses these assessments and forecasts to develop energy policies that conserve resources, protect the environment, ensure energy reliability, enhance the state's economy, and protect public health and safety.

Senate Bill 1389 (Bowen and Sher, Chapter 568, Statutes of 2002) directs state government entities to use the information and analyses contained in the adopted IEPR to carry out their energy-related duties and responsibilities. The CEC has coordinated closely with other agencies to ensure consistency in the underlying information used to develop this report.

Commissioner Patty Monahan is the lead for Volume I and leads the overall 2020 IEPR Update while Chair David Hochschild is the lead for Volume II, and Commissioner J. Andrew McAllister is the lead for Volume III. The 2020 IEPR Update lead commissioner issued a scoping order on February 24, 2020, identifying topics to cover in the report. As detailed in the scoping order, the *2020 IEPR Update* is composed of three volumes:

- **Volume I: Blue Skies, Clean Transportation**, focuses on California’s transportation future and the transition to zero-emission vehicles (ZEVs). Volume I is the focus of the *2020 IEPR Update*.
- **Volume II: The Role of Microgrids in California’s Clean and Resilient Energy Future**, examines microgrids, exploring how they can contribute to a more resilient energy system.
- **Volume III: California Energy Demand Forecast Update**, provides an update on California’s energy demand outlook, updated to reflect the global COVID-19 virus pandemic and to help plan for a growth in zero-emission plug in electric vehicles.

The CEC held 12 workshops between May 2020 and December 2020 on the topics identified in the scoping order. Information from the workshops and public comments were key inputs in developing the *Draft 2020 IEPR Update*. All workshop documents, including agendas, background material, transcripts, presentations, and public comments, are available on the CEC’s 2020 IEPR Update [web page](https://www.energy.ca.gov/data-reports/reports/integrated-energy-policy-report/2020-integrated-energy-policy-report-update-0) at <https://www.energy.ca.gov/data-reports/reports/integrated-energy-policy-report/2020-integrated-energy-policy-report-update-0>.

The CEC is modifying the schedule of the *2020 IEPR Update* such that each volume is being released separately rather than all three at once. Volume I was made publicly available on January 6, 2021, with a request for public comments by January 20, 2021. Public comments on Volume III are requested by February 18. Volume II will be available for public comment at a later date. Under the direction of the lead commissioner for each volume, the CEC will carefully consider public comments received and will propose changes to the report in response to these comments and to reflect market developments. A final version of each volume will then be made publicly available prior to the Business Meeting when the CEC will consider adopting each volume. The CEC anticipates considering adoption of Volume I at the March 17, 2021, Business Meeting and possible adoption of Volume III at the April 14, 2021, Business Meeting. The CEC anticipates adopting Volume II at the May 12, 2021, Business Meeting.

Public Comment

Written comments on *Draft 2020 IEPR Update, Volume III: California Energy Demand Forecast Update* must be submitted to the Docket Unit by **5:00 p.m. on February 18, 2021**. Written and oral comments, attachments, and associated contact information (including address, phone number, email address) will become part of the public record of this proceeding with access available via any internet search engine.
