Background

Assembly Bill 1657 (Garcia, Chapter 271, 2020) (AB 1657) requires that the California Energy Commission (CEC) establish and convene the Blue Ribbon Commission on Lithium Extraction in California (referred to as the Lithium Valley Commission), which is charged with reviewing, investigating, and analyzing certain issues and potential incentives regarding lithium extraction. Additionally, the Lithium Valley Commission is required to submit a report to the legislature documenting its findings and recommendations on or before October 1, 2022.
