Notice to Consider Adoption of Draft Commission Guidelines for the California Schools Healthy Air, Plumbing, and Efficiency Programs

As part of the California Energy Commission's (CEC) June 9, 2021 business meeting, the CEC will consider adoption of the Draft Commission Guidelines for both the California Schools Healthy Air, Plumbing, and Efficiency (CalSHAPE) Ventilation Program and the CalSHAPE Plumbing Program.

The business meeting will be held remotely, consistent with Executive Orders N-25-20 and N-29-20 and the recommendations from the California Department of Public Health to encourage physical distancing to slow the spread of COVID-19. The public can participate in the business meeting consistent with the direction in these executive orders. There will be opportunities for public comment. Instructions for remote participation and a detailed agenda will be posted prior to the CEC's Business Meeting. Background

The School Energy Efficiency Stimulus (SEES) Program was enacted by Assembly Bill (AB) 841 (Ting, Chapter 372, Statutes of 2020) and includes two grant programs: the School Reopening Ventilation and Energy Efficiency Verification and Repair Program, referred to as the CalSHAPE Ventilation Program, and the School Noncompliant Plumbing Fixture and Appliance Program, referred to as the CalSHAPE Plumbing Program.

The CalSHAPE Ventilation Program provides funding to California schools to assess, maintain, and repair ventilation systems, prioritizing schools in underserved communities as defined by AB 841. The CalSHAPE Plumbing Program provides funding to California schools and state agencies to replace aging and inefficient plumbing fixtures and appliances with water-conserving plumbing fixtures and appliances, also prioritizing schools in underserved communities as defined by AB 841.
