- DACAG members
- CPUC staff
 - CPUC energy efficiency programs generally designed to produce cost effective savings, but some programs focus on low income or certain geographic areas. Other programs that support the portfolio but don't generate savings – marketing, workforce development, etc. Created challenges for administrators to balance their portfolios in a way that serves DAC customers. New CPUC approach – D.21-05-031 segmented portfolio – resource acquisition for CE energy savings, equity to serve DAC and geographically isolated customers not served by ESA, and market support. Will be assigned metrics to be designed by CAEECC, which will form working groups to create segment-specific metrics – welcome participation in all segments. CPUC staff will share information on how to participate.
