*IN THE MATTER OF:***GENERAL ADMINISTRATIVE PROCEEDING****Docket No.: 11-GEN ADMIN-01****STANDING ORDER REGARDING NUMBER OF COPIES REQUIRED FOR APPLICATIONS FOR CERTIFICATION, SMALL POWER PLANT EXEMPTIONS, NOTICES OF INTENT, AMENDMENTS, AND FORMATTING.****I. PURPOSE OF ORDER**

California Code of Regulations, title 20, section 1706,¹ directs the California Energy Commission's (CEC) Executive Director to specify the format and number of copies to be submitted to the CEC for Notices of Intent, Applications for Certification, and any amendments to be filed under the CEC's power plant siting programs. This Standing Order (Order) also applies to Applications for Opt-In Projects, Strategic Reliability Reserve Department of Water Resources (DWR) applications, and Small Power Plant Exemption applications.

This Order supersedes three previous Standing Orders, dated November 30, 2011,² August 29, 2013³ and September 20, 2016.⁴ Those previous orders are hereby revoked and shall have no force or effect after this Order is filed with the CEC's Docket Unit.

II. FORMATTING

In addition to the requirements for filing of documents as set forth sections 1208 and 1208.1, for Notices of Intent, Applications for Certification, Applications for Opt-In Projects, DWR applications, Small Power Plant Exemption applications and amendments to certifications, applicants must file all documents electronically through the CEC's docket system. Providing physical copies of documents, such as paper, CDs, or DVDs is not necessary. If a file is too large or otherwise cannot be filed through the CEC's docket system, the applicants shall contact
